**Getting Started:** When it is your turn to speak during the public forum portion of the agenda, please stand and state your name to the board of education.

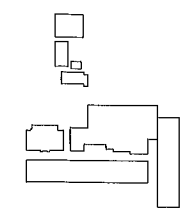
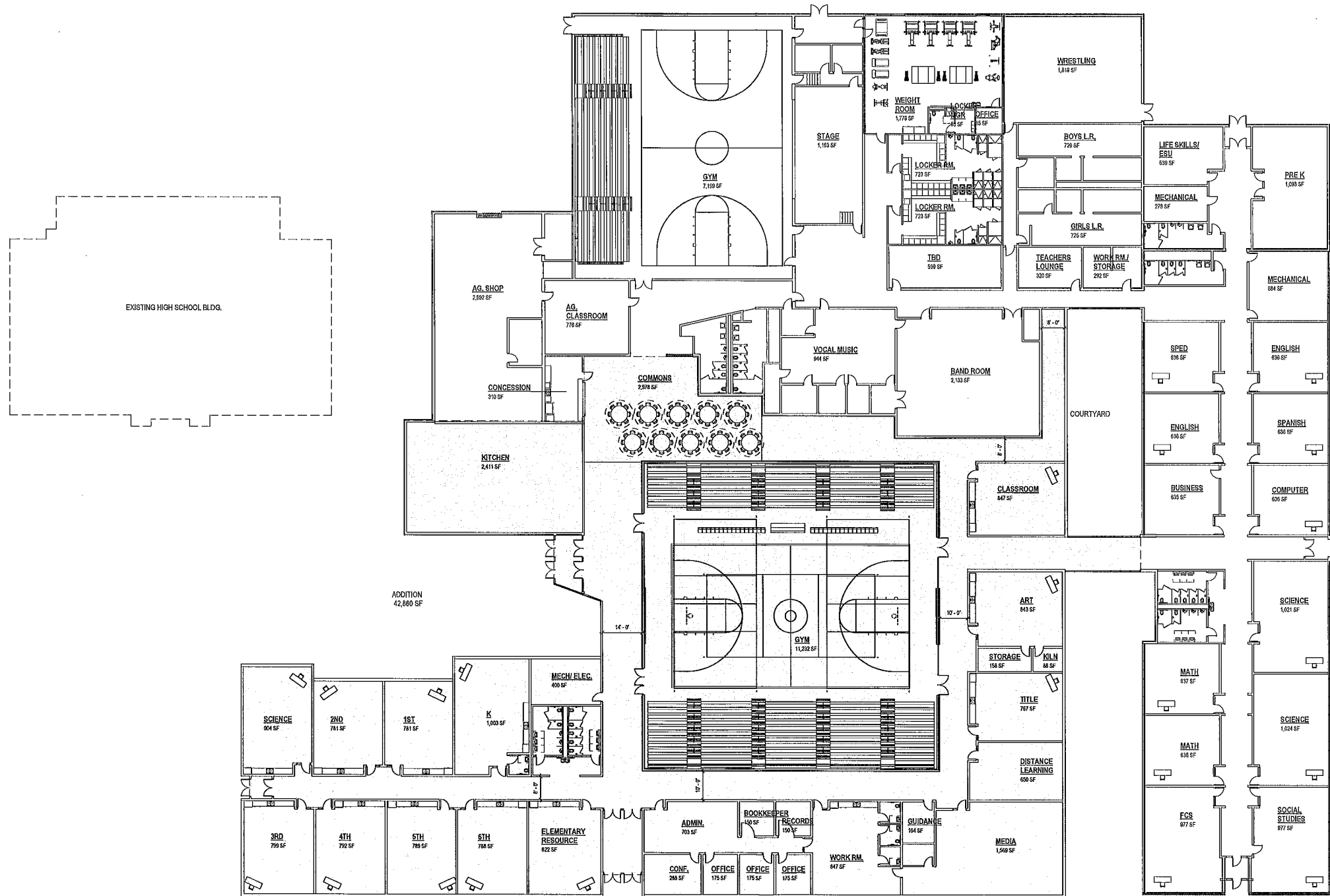
**Time Limit:** You may speak only one time and must limit comments to 5 minutes or less.
